You have the right to access, rectify and delete the data, as well as other rights, as explained in our privacy policy.

#### Who is the Data Controller responsible for your data?

#### For what purpose are my personal data processed?

The collection and automated processing of personal data is intended to maintain the commercial relationship and to perform commercial information tasks on the activities of SABACAUCHO itself.

In addition, we hereby inform you that we will prepare a "commercial profile" based on the information provided by you and that derived from your consumption and browsing habits so we can offer SABACAUCHO products and services suited to your interests and improve your user experience of our website.

#### How long will we keep your data?

The personal data provided will be kept as long as the commercial relationship lasts, until you request their deletion or for as long as legal liabilities could arise for the services rendered.

#### What is the legitimate basis for the processing of your data?

The legal basis for processing your personal data is the implementation and maintenance of the relationship maintained with you; the express consent that, if applicable, you have provided for us for additional processing, so we can send our own commercial communications and/or those of third parties; and the preparation of commercial profiles, with the purposes indicated in the section "For what purpose are my personal data processed?".

We hereby inform you that the personal data requested when registering on this website, or when filling in any of our paper format forms, are strictly necessary to formalise and manage the relationship with you; if you do not provide them, we cannot maintain this relationship. In no case does this main purpose include consent for processing data not necessary for this main activity.

The prospective offer of our products and services and the preparation of commercial profiles are additional processing based on the consent requested, without the withdrawal of this consent affecting the maintenance of the relationship maintained with us.

### What are your rights when you provide us with your data?

Interested persons have the right to access their personal data, request the rectification of inaccurate data and request its deletion, where appropriate, when, for example, the data is no longer necessary for the purposes they were collected, among other reasons.

In certain circumstances, interested parties may request the limitation of the processing of their data; in which case we will keep them only for exercising or defending against claims.

In certain circumstances, for reasons related to their particular situation, interested parties may object to the processing of their data. SABACAUCHO will stop processing the data, except for compelling legitimate reasons or to exercise or defend against possible claims.
